

## Agreement for processing of personal data

By joining this Agreement and submitting his data to [creonenergy.ru](http://creonenergy.ru) (hereinafter the Website) by means of filling out the online registration form, the User:

- confirms that all the submitted data are his personal data;
- confirms and acknowledges that he has read in full the Agreement and the terms of processing his personal data submitted in the fields of the online registration form; the text of the Agreement and the terms for personal data processing are clear to him;
- gives consent to the Website to process his personal data contained in the information submitted for the purposes of conclusion of the present Agreement between him and the Website, and for the purposes of subsequent execution of the Agreement;
- agrees with the terms of personal data processing without reservations and limitations.

The User gives his consent for the processing of his personal data, in particular to the actions stipulated in part 3 article 1 of the «Personal Data» Federal Law #152-ФЗ dated 27.07.2006, and confirms that when giving his consent he is acting voluntarily, on his own will and in his own interest.

The User's consent for the processing of personal data is specific, informed, and conscious.

The present consent is recognized fulfilled in written form and applies to processing of the following personal data: last, first and middle names; phone numbers; e-mail addresses.

The User entitles [creonenergy.ru](http://creonenergy.ru) to following operations with personal data: collection and accumulation; storage during the period established by regulatory documents, but not less than three years from the date of termination of use of the services by the User; update (renewal, change); use; liquidation; anonymization; disclosure by order of the court, including disclosure to third parties, in compliance with the measures ensuring protection of personal data against unauthorized access.

The abovementioned consent remains in force without limit of time starting from the moment of submitting the data and can be revoked by the User by filing the application to the Website administration with indication of data specified in article 14 of the «Personal Data» Federal Law.

To revoke the consent for the processing of personal data, a relevant order in writing can be submitted to the e-mail address [it@creonenergy.ru](mailto:it@creonenergy.ru)

The Website is not responsible for the use, neither lawful nor wrongful, by the third parties of the Information posted by the User on the Website, including reproduction and distribution carried out in any possible way.

The Website has the right to introduce amendments to the present Agreement. If amendment is made, the revised version of the Agreement shall contain the date of the latest amendment. The revised version of the Agreement comes into force upon its publication, unless otherwise stipulated in the revised Agreement.
